DOES ACCESS MATTER? TIME IN GENERAL EDUCATION AND ACHIEVEMENT FOR STUDENTS WITH DISABILITIES

A study was conducted to examine the relationship between hours in general education and achievement in reading and math for students with disabilities. Of course as we all know that there is a direct correlation between the number of hours spent with non-disabled peers and academic success. The power of this study is that it goes one step further and clearly defines the difference between "Accessto general education contexts vs "Inclusion." The most powerful outcome that I glean from my review of the study is the importance of evaluating our district policies and practices that can either lend itself towards equity for all students, which lead to increases in achievement for students with and without disabilities and the importance of moving from a continuum of placements model to a continuum of service delivery model. Last but not least, it is equally important to examine policies and practices within our classrooms.
